ORDINANCE NO. 1987-M-35

AN ORDINANCE AMENDING CHAPTER 5.32 "REFUSE COLLECTORS"  
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.32 "Refuse Collectors," Section 5.32.020  
"License - Application - Issuance" of the St. Charles Municipal Code  
be and is hereby amended by deleting 5.32.020 and substituting the  
following therefore:

"5.32.020 License - Application - Issuance - Renewal.

Application for such license shall be made to the city clerk, prior to May 1st of a calendar year, and shall be referred by him to the mayor and city council for recommendation; no such license shall be issued except on order of the mayor and city council. A renewal license may be issued by the mayor provided the licensee has duly completed the required application, given the information required and paid the appropriate fee. In the event the same has not been completed on or before May 1 of the license year, the mayor shall conduct a public hearing by the mayor and city council with a three-day written notice to the licensee, affording the licensee an opportunity to appear and defend such notice to begin the day following delivery by certified mail or by the city police department acting as agent for the mayor and city council. No more than six refuse collectors' licenses shall be in force in the city at any one time. Each collector must file with the city clerk a list of its charges for commercial, business and industrial establishments on or before May 1st of each calendar year."


