



ORDINANCE NO. 1988-M-18

AN ORDINANCE AMENDING TITLE 2 "ADMINISTRATION AND PERSONNEL"
CHAPTER 2.30 "FIRE DEPARTMENT" OF
THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL of the CITY OF
ST. CHARLES, KANE and DUPAGE COUNTIES, ILLINOIS, that:

1. Title 2, "Administration and Personnel", Chapter 2.30 "Fire Department" of the St. Charles Municipal Code, be and is hereby amended by deleting Section 2.30.010 and substituting the following therefor:

"2.30.010 Created - Composition.


There is created a fire department, an executive department of the city. The full-time fire department shall consist of the fire chief, assistant fire chief, three captains, nineteen firemen, and such additional members as may be provided for from time to time by the mayor and city council. Such additional members of the fire department are to be known as paid-on-call firemen. The paid-on-call firemen shall not exceed fifty in number and not less than thirty. Within this group a yearly election shall be held to elect a president, secretary, treasurer and such other members as may be provided for from time to time. All members of the fire department including the fire chief are to be considered employees of the city. "

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the City Council, or (ii) within thirty (30) days after adoption and approval hereof, be published in a newspaper of general circulation within the City of St. Charles.
