ORDINANCE NO. 1988-M-67

AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC".  
CHAPTER 10.40., "STOPPING, STANDING AND PARKING",  
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.

CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.010, "Parking Time Limits", of the St. Charles Municipal Code, be and is hereby amended by deleting Subparagraph "E(5)", "E(6)", and "E(7)" therefrom; and adding Subparagraph "C", "D" and "E" to Section 10.40.045, "Residential Parking Only" of the St. Charles Municipal Code, as follows:

C. On the south side of Fairfax Road from the westerly right-of-way of Dunham Road to the easterly right-of-way of Forest Ridge Road.

D. On both sides of Canidae Court from the southerly right-of-way of Chasse Circle.

E. On both sides of Shire Lane from the westerly right-of-way of Chasse Circle.

2. The Superintendent of Streets and Sewers shall cause signs to be posted in all areas where parking is prohibited, indicating such prohibitions.


3. Any person who violates any of the provisions of this Ordinance shall, upon conviction, be fined not less than Ten Dollars (\$10.00) nor more than Five Hundred Dollars (\$500.00) for each offense, and each day shall be considered a separate offense.

4. That after the adoption and approval hereof, this Ordinance shall (a) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles.
