**AN ORDINANCE AMENDING CHAPTER 2.33, "OFFICE OF PURCHASING", SECTION 2.33.160, "COMPETITIVE BIDDING REQUIRED", OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 2.33, "Office of Purchasing", Section 2.33.160, "Competitive Bidding Required", of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

**"2.33.160 Competitive bidding required.**

All purchases of, and contracts for supplies and contractual services, in excess of five thousand dollars and all sales of personal property which has become obsolete and/or unusable shall, except as specifically provided in this chapter, be based wherever possible on competitive bids, unless otherwise authorized by the city council."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


