AN ORDINANCE AMENDING CHAPTER 5.08, "ALCOHOLIC BEVERAGES" OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.340, "Closing hours", of the St. Charles Municipal Code, be and is hereby amended by adding the following thereto:


- "F. All Class Q license holders at all times except between 1:00 a.m. Saturday morning and 2:00 a.m. Saturday morning.
- G. All Class R license holders between the hours of 12:00 midnight and 10:00 a.m. on all days except Sunday, between the hours of 12:00 midnight and 12:00 noon on Sunday, between the hours of 9:00 p.m. and midnight on Monday, Tuesday, Wednesday and Thursday and between the hours of 10:00 p.m. and midnight on Friday and Saturday."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
