


ORDINANCE NO. 1988-M-74

AN ORDINANCE AMENDING CHAPTER 5.08, "ALCOHOLIC BEVERAGES" OF THE ST. CHARLES MUNICIPAL CODE



BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.090, of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

"5.08.090 License - Number to be issued.

There shall be issued not more than a maximum of seven class A, thirteen class B, eleven class C, one class D, one class E, three class F, and permitted supplementary license for Class D licenses in any license year, four class I, plus one license for each of the special restricted classes as set forth in this chapter, twenty class N licenses, plus one class O license, one class P license, plus one class R license."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
