

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 13.16 "Water," Section 13.16.190 "Net charges for property with buildings connected to system" of the St. Charles Municipal Code be and is hereby amended by deleting the same and substituting the following therefor:

**"13.16.190 Net charges for property with buildings connected to system.**

All property upon which any building has been or may be hereafter erected having a connection with the water system shall pay the following charges:

A. General Water Service

1. Customer Charge. The following customer charge is for all general water service customers:

<u>Meter Size</u>	<u>Customer Charge</u> <u>Per Month</u>
5/8" or less	3.00
3/4"	3.00
1"	3.30
1-1/4"	3.90
1-1/2"	4.15
2"	4.60
3"	6.00
4"	8.25
6"	14.00
8"	20.50

2. Water Charge. The proposed water rate applies to all customers:

0 - 50	Mgal/Mo	1.10 per 1000 gallons
51 - 2000	Mgal/Mo	1.06 per 1000 gallons
Over 2000	Mgal/Mo	1.00 per 1000 gallons

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
