

AN ORDINANCE AMENDING CHAPTER 2.33, "OFFICE OF PURCHASING", SECTIONS 2.33.160, "COMPETITIVE BIDDING REQUIRED", 2.33.170, "FORMAL CONTRACT PROCEDURE - REQUIRED WHEN", AND 2.33.340, "EMERGENCY PURCHASES - MANAGER", OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.33, "Office of Purchasing", Sections 2.33.160, "Competitive Bidding Required", 2.33.170, "Formal Contract Procedure - Required When", and 2.33.340, "Emergency Purchases - Manager", of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

2.33.160 Competitive bidding required.

All purchases of, and contracts for supplies and contractual services, in excess of ten thousand dollars and all sales of personal property which has become obsolete and/or unusable shall, except as specifically provided in this chapter, be based wherever possible on competitive bids, unless otherwise authorized by the city council.

2.33.170 Formal contract procedure - Required when.


When the estimated cost of supplies and/or contractual, services exceeds ten thousand dollars (\$10,000.00) they shall be purchased by formal, written contract from the lowest responsible bidder after notice inviting proposals except as otherwise specified in this chapter or otherwise authorized by the city council.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I, Jean M. Connors, certify that I am the duly elected and acting municipal clerk of the City of St. Charles, Kane and DuPage Counties, Illinois.
