NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:


1. That Section 5.08.080, "License Number to be issued", of Chapter 5.08, "Alcoholic Beverages", of the St. Charles Municipal Code, be and is hereby amended by increasing the Class B liquor licenses by one so that the number shall be fourteen.

2. This Ordinance shall be in full force and effect from and after its passage and approval in accordance with law.
