AN ORDINANCE AMENDING CHAPTER 6.12 "ANIMALS:
REGULATIONS" OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:

1. That Chapter 6.12 "Animals: Regulations" of the St.
Charles Municipal Code be and is hereby amended by adding
the following section:

**"6.12.160 Limit of Number of Dogs and Cats per
Household.**


No person shall possess more than a total of
three dogs and/or cats in any household,
apartment or other dwelling unit within the
City. Any dwelling unit containing more than
a total of three dogs and/or cats is hereby
deemed a nuisance, and any person who violates
this Ordinance shall be subject to the
enforcement provisions under this title."

2. That after the adoption and approval hereof this
Ordinance shall (i) be printed or published in book or
pamphlet form, published by the authority of the Council,
or (ii) within thirty (30) days after the adoption and
approval hereof, be published in a newspaper published in
and with a general circulation within the City of St.
Charles.
