WHEREAS, the City utilizes the services of Kane County in connection with animal control and in order to effectuate such intergovernmental agreement a modification of the term "animal control officer" is needed.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:

1. That Title 6, "Animals", Chapter 6.04, "Definitions" of the St. Charles Municipal Code, be and is hereby amended by deleting Section 6.04.040, "Animal control officer" and substituting the following therefor:

"6.04.040 Animal control officer.

'Animal control officer' means an employee of the city who shall have the power and authority to enforce the provisions of this title and shall where appropriate be the employee of Kane County who implements the provisions of this title pertaining to animals pursuant to an intergovernmental agreement with the city."


2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval

hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
