BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, as follows:

1. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.010, "Parking Time Limits", of the St. Charles Municipal Code, be and is hereby amended by deleting the following:

E.2 "Southgate Course from the southerly right-of-way of Fox Chase Boulevard."

2. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10, 40.045, Residential Parking Only", of the St. Charles Municipal Code, be and is hereby amended by adding the following:

F. "Southgate Course from the southerly right-of-way of Fox Chase Boulevard."

3. The City Engineer shall cause signs to be posted in all areas where parking is restricted, indicating such restrictions.

4. Any person who violates any of the provisions of this Ordinance shall, upon conviction, be fined not less than Ten Dollars (\$10.00) nor more than Five Hundred Dollars (\$500.00) for each offense.


5. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in

a newspaper published in and with a general circulation within  
the City of St. Charles.
