

**AN ORDINANCE AMENDING CHAPTER 2.28, "PLAN COMMISSION",  
SECTION 2.28.010, "COMPOSITION - MEMBERS' APPOINTMENT",  
OF THE THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.  
CHARLES, KANE AND DU PAGE COUNTIES ILLINOIS, AS FOLLOWS:**

1. That Chapter 2.28, "Plan Commission", Section 2.28.010, "Composition - Members' Appointment", of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

**"2.28.010 Composition - Members' appointment.**


The plan commission of the city shall consist of the mayor who shall be an ex officio member and eleven additional members who shall be appointed by the mayor with the advice and consent of the city council. No more than three members of the plan commission shall be appointed from any ward of the city. In the event a member moves from one ward to another, or if there is a change in the ward boundaries which changes the number of members in any ward so there shall be more than three, no such member shall be required to resign nor shall the Mayor be prohibited from reappointing any such member even though the number of members from the ward in which he or she then resides shall continue to be more than three."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
