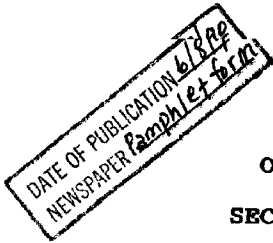

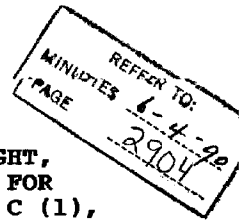

ORDINANCE NO. 1990-M- 49



AN ORDINANCE AMENDING CHAPTER 10.15, "SIZE, WEIGHT,
LOAD AND PERMITS", SECTION 10.15.410, "PERMITS FOR
OVERWEIGHT VEHICLES AND EXEMPTIONS", SUBPARAGRAPH C (1),
AND CHAPTER 10.40, "STOPPING, STANDING AND PARKING",
SECTION 10.40.010, "PARKING TIME LIMITS", SUBPARAGRAPH C (1)
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDIANED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 10.15, "Size, Weight, Load and
Permits", Section 10.15.410, "Permits for Overweight
Vehicles and Exemptions", Subparagraph C (1), and Chapter
10.40, "Stopping, Standing and Parking", Section 10.40.010,
"Parking Time Limits", Subparagraph C (1) of the St. Charles
Municipal Code, be and is hereby amended by deleting the
same and substituting the following therefor:

"10.15.410 (C) (1):

1. Emergency vehicles and service vehicles of
public utilities as authorized by the Chief of
Police;"

"10.40.010 (C) (1):

1. Except for service vehicles of public utilities,
it is unlawful to park any pickup camper with a
cap that exceeds six inches above the cab roof,
a van that exceeds its manufacturer's height,
motor home, mobile home, trailer, boat trailer,
tractor, bus, truck which has a gross carrying
weight in excess of three-fourths ton, and any
vehicle of the first or second division, as
defined in the Illinois Revised Statutes,
Chapter 95 1/2, Paragraph 1-217 (1983 ed), which
is equipped with an attached snowplow, on any
street, alley, or parkway between the hours of
10 p.m. and 7 a.m."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
