BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.020, of the St. Charles Municipal Code, be and is hereby amended by adding Subsection "H" as follows:

"H. Parking on the Tree Bank: No person shall cause, permit or allow a vehicle to be parked on the tree bank, which is the area between the right-of-way line and the curb of the street, unless such area shall have been paved and approved by the Director of Public Works of the City of St. Charles, or his designee, or unless the Director of Public Works, or his designee, has declared a snowstorm emergency and then only during the time such snowstorm emergency remains in effect."

2. The Director of Public Works or any other person authorized by the Mayor and City Council shall cause "no parking" signs to be posted as provided herein.

3. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than ten dollars (\$10.00) nor more than five hundred dollars (\$500.00) for each offense.


4. That after the adoption and approval hereof, the ordinance shall be printed or published in book or pamphlet form, published by the authority of the City Council, or (b)

within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
