AN ORDINANCE AMENDING CHAPTER 2.30, "FIRE DEPARTMENT"
SECTION 2.30.010, "CREATED - COMPOSITION",
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 2.30, "Fire Department", Section 2.30.010,
"Created - Composition", of the St. Charles Municipal Code, be and
is hereby amended by deleting the same and substituting the
following therefor:

"2.30.010 Created - Composition.


There is created a fire department, an executive
department of the city. The full-time fire department
shall consist of the fire chief, assistant fire chief,
three captains, four lieutenants, twenty firemen, and
such additional members as may be provided for, from time
to time, by the mayor and city council. Such additional
members of the fire department are to be known as paid-
on-call firemen. The paid-on-call firemen shall not
exceed fifty in number and not less than thirty. Within
this group a yearly election shall be held to elect a
president, secretary, treasurer and such other members as
may be provided for from time to time."

2. That after the adoption and approval hereof the Ordinance
shall (i) be printed or published in book or pamphlet form,
published by the authority of the Council, or (ii) within thirty
(30) days after the adoption and approval hereof, be published in
a newspaper published in and with a general circulation within the
City of St. Charles.
