BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic", Chapter 10.40,"
Stopping, Standing and Parking", Section 10.40.010, "Parking time
limits", of the St. Charles Municipal Code, be and is hereby
amended by deleting Section E in its entirety.

2. That Title 10, "Vehicles and Traffic", Chapter 10.40,"
Stopping, Standing and Parking", Section 10.40.040, "No-Parking
Places Designated-Prohibited Parking", of the St. Charles Municipal
Code, be and is hereby amended by deleting Exhibits A-4 and A-7 and
substituting the attached Exhibits A-4 and A-7 therefor.

3. That Title 10, "Vehicles and Traffic", Chapter 10.40,"
Stopping, Standing and Parking", Section 10.40.045, "Residential
Parking Only", of the St. Charles Municipal Code, be and is hereby
amended by adding the following thereto:

"G. Dunham Place along the northerly
side of the street from the westerly
right-of-way of Dunham Road and
continuing westerly around the
circle on the outer edge thereof to
Dunham Road as more fully shown in
the Exhibits appended to this Code."

4. That after the adoption and approval hereof the Ordinance
shall (i) be printed or published in book or pamphlet form,
published by the authority of the Council, or (ii) within thirty
days after the adoption and approval hereof, be published in a

newspaper published in and with a general circulation within the City of St. Charles.
