

AN ORDINANCE AMENDING CHAPTER 13.16 "WATER"
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 13.16 "Water," Section 13.16.190 "Net charges for property with buildings connected to system," and 13.16.050 "Connection Fees" of the St. Charles Municipal Code be and is hereby amended by deleting the same and substituting the following therefor:

"13.16.190 Net charges for property with buildings connected to system.

All property upon which any building has been or may be hereafter erected having a connection with the water system shall pay the following charges:

A. General Water Service

1. Customer Charge. The following customer charge is for all general water service customers:

<u>Meter Size</u>	<u>Customer Charge Per Month</u>
5/8" and under	3.50
3/4"	3.50
1"	3.75
1-1/4"	4.35
1-1/2"	4.70
2"	5.20
3"	6.85
4"	9.30
6"	15.50
8"	23.00

2. Water Charge. The following proposed water rates apply to all customers:

Base Water Rate	1.40 per 1000 gallons
*Excess Seasonal Water Rate	2.30 per 1000 gallons

*Excess Seasonal Water Rate applies to customers' first monthly billing period with an ending meter reading date on or after May 15th and the next four succeeding monthly billing periods.

The excess seasonal water rate applies to water used per month during the above period which is greater than 130 percent of the monthly average of water used during the winter quarter and which is greater than 6,500 gallons per month usage. All other water used is billed at the base water rate.

New customers who have no history of water consumption during a winter quarter will be billed on the basis of actual consumption at a base rate until a winter average is determined.

"13.16.050 Connection fees.

The fee for each permit allowing connection with the city water system shall be as follows:

A. Residential Dwelling Units

1. Single and multiple family dwelling units.

<u>Class</u>	<u>Description</u>	<u>Sq. Feet</u>	<u>Connection Fee</u>
1	Dwelling Unit	Over 1000	925
2	Dwelling Unit	Under 1000	700
3	Dwelling Unit	800 Maximum	620

B. Other Uses


1. All users other than single or multifamily dwelling units, described in Subsection A above, shall pay a connection fee based upon the estimated daily maximum (i.e., peak) water usage as determined by the City Engineer. The Building Commissioner and/or City Engineer may require the applicant to provide an estimate certified to by an engineer licensed in the state of Illinois. The charge per gallon of daily maximum (i.e., peak) water usage for calculating the connection fee is \$1.54. In no case shall the connection fee be less than the charge for a Class 1 dwelling unit.
2. Once the actual usage begins and it is determined that the actual daily maximum (i.e., peak) water usage is larger than the estimated maximum (i.e., peak) water usage, there will then be an additional fee for the gallons over the original estimated daily maximum (i.e., peak) water usage based on \$1.54 per gallon. There will be no rebates if the actual daily maximum (i.e., peak) water usage falls below the estimated daily maximum (i.e., peak) water usage.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles. However, the ordinance shall not be effective before June 15, 1992.


