WHEREAS, mailboxes have been found to be too close to the street, thereby creating problems for snow plowing operations within the City of St. Charles.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:


1. That Title 12 entitled, "Streets, Sidewalks and Public Places," Chapter 12.04, entitled "General Provisions," of the St. Charles Municipal Code be and is hereby amended by adding Section 12.04.218 as follows:


"12.04.218 - Mailbox Installation And Placement.

Mailboxes shall be installed at a minimum height of 42" above grade and a maximum of 48" above grade. The face of the box shall be a minimum of 12" and a maximum of 18" from the back of the curb or edge of the pavement as the case may be . A diagram of the permissible placement is shown in Attachment A."



That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, by published in a newspaper published in and with a general circulation within the City of St. Charles.
