AN ORDINANCE AMENDING CHAPTER 10.40,
"STOPPING, STANDING AND PARKING,"
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking," Section 10.40.050, "Permit parking - City parking lots," of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefore:

"10.40.050 Permit parking - City parking lots.

A. Parking Lot B. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in the leased portion of the parking lot shown in Exhibit "B," of this chapter unless there is displayed in the rear window thereof a reserved parking permit authorized by the city. The foregoing sentence shall apply only between the hours of 8:00 a.m. and 5:00 p.m. on Monday, Tuesday, Thursday, and Friday, and between the hours of 8:00 a.m. and 12:00 p.m. Wednesday and Saturday, except when any of such days shall fall on a Bank holiday.

B. Parking Lot D. It is unlawful for any person to cause, allow, or permit any vehicle to be parked in the leased portion of the parking lot shown in Exhibit "D" of this chapter unless there is displayed in the rear window thereof a reserved parking permit authorized by the city. The foregoing sentence shall apply only between the hours of 8:00 a.m. and 6:00 p.m. on Monday, Tuesday, Wednesday, Thursday, Friday, and Saturday."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a

newspaper published in and with a general circulation within the City of St. Charles.






