

ORDINANCE NO. 1993-M- 61

**AN ORDINANCE AMENDING CHAPTER 10.40,
"STOPPING, STANDING AND PARKING",
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic", Chapter 10.40, "Stopping, Standing and Parking", Section 10.40.045, "Residential Parking only", of the St. Charles Municipal Code, be and is hereby amended by adding thereto Subparagraph "H" as follows:

"H. On both sides of 8th Street from the northerly right-of-way of Oak Street to the southerly right-of-way of Indiana Street, except for the southerly 150 feet along the East side of 8th Street as measured northerly from the north line of Oak Street."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on November 1, 1993, the Corporate Authorities of such municipality passed and approved Ordinance No. 1993-M-61, entitled
