

**AN ORDINANCE AMENDING TITLE 17, "ZONING",  
OF THE ST. CHARLES MUNICIPAL CODE REGARDING  
SPECIAL USES  
(Automobile Laundries In M-1 District)**

**WHEREAS**, a Petition dated June 30, 1992, has been filed to amend Title 17, "Zoning" of the St. Charles Municipal Code to add automobile laundries as a special use in the M-1 Limited Manufacturing District; and

**WHEREAS**, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with laws; and

**WHEREAS**, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

1. That Title 17, "Zoning", of the St. Charles Municipal Code be and is hereby amended as follows:

Section 17.36.020 "Special Uses", (M-1 Limited Manufacturing District) is hereby amended by adding the following, in alphabetical order:

"Automobile Laundries"

and by renumbering the list of Special Uses accordingly.

2. That this Ordinance shall become effective from and after its passage and approval in accordance with law.


