

**AN ORDINANCE AMENDING CHAPTER 10.41, "HANDICAPPED PARKING",
SECTION 10.41.050, "POSTING SIGNS",
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 10.41, "Handicapped Parking", Section 10.41.050, "Posting Signs", of the St. Charles Municipal Code, be and is hereby amended by adding thereto the following:

"D. On-street public parking, Main Street (Route 64), one space directly in front of One West Main Street on the south side of Main Street (Route 64), as identified and properly signed."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


