**AN ORDINANCE AMENDING TITLE 2, "ADMINISTRATION AND PERSONNEL", CHAPTER 2.32, "POLICE DEPARTMENT", SECTION 2.32.010, "CREATED-COMPOSITION", OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 2, "Administration and Personnel", Chapter 2.32, "Police Department," Section 2.32.010, "Created - Composition" of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

**"2.32.010 Created - Composition**

There is created a Police Department, an executive department of the City. The Police Department shall consist of the Chief of Police, two lieutenants, nine sergeants, thirty-six patrol officers, and such other members that may be provided for from time to time by the Mayor and City Council. All appointed police officers of the Police Department, including the Chief of Police, are to be considered employees of the City."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
