**AN ORDINANCE AMENDING CHAPTER 2.04 "CITY COUNCIL"
OF THE ST. CHARLES MUNICIPAL CODE
(CALLING COMMITTEE MEETINGS)**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 2.04, "City Council", of the St. Charles Municipal Code, be and is hereby amended by adding Section 2.04.095, "Standing Committees --Special Meetings".

"2.04.095 Standing Committees--Special Meetings.

Special meetings of a standing committee may be called by the committee chairman or a majority of the committee members; provided, that a written notice of such meeting shall be given to each member of the committee at least forty-eight hours before the time set for the meeting, except in cases of emergency as determined by the committee; and provided further, that in case all of the elected members of the committee are present at any such special meeting, then the requirement of written notice to such committee members shall be unnecessary and shall be deemed waived."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles.


