

**AN ORDINANCE AMENDING CHAPTER 9.08,
"ASSAULT AND BATTERY",
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 9.08, "Assault and Battery", Section 9.08.030, " Reckless conduct prohibited", of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

"9.08.030 Reckless conduct prohibited.


It is unlawful to commit reckless conduct. A person who causes bodily harm to, or endangers the bodily safety of, an individual by any means, commits reckless conduct if he performs in a reckless manner, the acts which cause the harm or endanger the safety, whether they otherwise are lawful or unlawful."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




