

**ORDINANCE NO. 1995-M- 11**

**AN ORDINANCE AMENDING CHAPTER 5.08, "ALCOHOLIC BEVERAGES", OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.080, "License - Classes and fees", of the St. Charles Municipal Code, be and is hereby amended by deleting Subparagraph "R".

2. That Chapter 5.08, "Alcoholic Beverages, Section 5.08.090, "License - Number to be issued", of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefor:

**"5.08.090 License - Number to be issued.**

There shall be issued not more than a maximum of nine class A, twenty-one class B, nine class C, one class D, one class E, three class F, and permitted supplementary license for class D licenses in any license year, seven class I, plus one license for each of the special restricted classes as set forth in this chapter, plus twenty class N licenses, provided, no more than two such class N licenses shall be issued for any twenty-four hour period, plus no more than two class O for any twenty-four hour period, plus one class P license."

3. That Chapter 5.08, "Alcoholic Beverages", Section 5.08.340, "Closing hours", of the St. Charles Municipal Code, be and is hereby amended by deleting Subparagraph "G".

4. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be

published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on April 3, 1995, the Corporate Authorities of such municipality passed and approved Ordinance No. 1995-M-11, entitled
