

AN ORDINANCE AMENDING TITLE 8, "HEALTH AND SAFETY,"
 CHAPTER 8.24 "GARBAGE AND REFUSE," OF THE
 ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
 KANE AND DUPAGE COUNTIES, ILLINOIS, as follows:

1. THAT TITLE 8, "Health and Safety," Chapter 8.24 "Garbage and Refuse," of the St. Charles Municipal Code be and is hereby amended by deleting Section 8.24.040 "Charges and Bills," and substituting the following therefore:

"8.24.040 Charges and bills.

- A. The charge for collection of each disposal unit or large household item for a non-multi-family dwelling, as defined herein, shall be assessed upon the purchase of a designated bag or sticker. Said designated bags or stickers may be purchased from various retail outlets in the city, at the prices set forth in Section 8.24.040 (B) hereof.
- B. The charges for garbage and rubbish, yardwaste and recyclable material collection service within the corporate limits of the city shall be as follows:

Multi-family complexes with twice a week service will receive an additional bill from the contracted hauler based on the number of occupied units for the following amounts:


- C. One pre-paid bag or one pre-paid sticker (as defined herein) shall be securely and visibly attached to (a) every container containing sod, earth and/or rocks; (b) every bundle or container of home remodeling and repair construction materials, not to exceed two (2) cubic yards; and (c) one pre-paid bag or sticker for each piece of furniture placed out for collection.
- D. 1. Multi-family Units: Bills for the collection of garbage and rubbish and recyclable material to multi-family dwellings being serviced by a dumpster shall be sent out monthly by the city. The due date of bills shall be fifteen days from the date of billing.
2. Multi-family complexes with twice a week service will be billed by the contracted hauler for the additional service per week based on the number of occupied units.
- E. Late payments shall include an additional ten percent charge."

2. That after the adoption and approval hereof, this Ordinance shall (a) be printed or published in book or pamphlet form, published by the authority of the City Council, or (b) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


