**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC",  
CHAPTER 10.11, "RULES OF THE ROAD", OF THE  
ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic", Chapter 10.11, "Rules of the Road", Section 10.11.1600, "Through streets", of the St. Charles Municipal Code, be and is hereby amended by adding Subsection 18 as follows:

"18. Fox Chase Boulevard from Stonehedge Road to Dunham Road."

2. The Director of Public Works or any other person authorized by the Mayor and City Council, shall cause stop signs to be posted as provided herein.

3. Any person, firm or corporation violating any provision of this ordinance shall be fined not less than ten dollars (\$10.00) nor more than five hundred dollars (\$500.00) for each offense.

4. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.






I further certify that on September 18, 1995, the Corporate Authorities of such municipality passed and approved Ordinance No. 1995-M-37, entitled
