ORDINANCE NO. 1996-M- 78

AN ORDINANCE AMENDING TITLE 5, "BUSINESS LICENSES AND REGULATIONS", OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 5 "Business Licenses and Regulations", Chapter 5.48, "Carnivals", Section 5.48.060, "Length and hours of operation", of the St. Charles Municipal Code, be and is hereby amended by deleting same and substituting the following therefor:

"5.48.060 Length and hours of operation.


- A. Any carnival licensed to operate in the City of St. Charles shall not remain in operation at any one location for a period not to exceed twelve (12) consecutive days, nor shall any carnival be located at any one location more than three (3) times during one calendar year.
- B. Carnivals shall not open for business prior to ten o'clock (10:00) a.m. in the morning, and shall not remain open later than eleven o'clock (11:00) p.m. on the same day or curfew time as specified in Chapter 9.52 of the St. Charles Municipal Code, whichever is earlier. A carnival operating at a permanent county fairground shall not remain open later than twelve o'clock (12:00) a.m. (midnight), and shall remain closed between twelve o'clock (12:00) a.m. (midnight) and ten o'clock (10:00) a.m."

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on November 18, 1996, the Corporate Authorities of such municipality passed and approved Ordinance No. 1996-M-78 entitled
