


ORDINANCE NO. 1997-M- 14

AN ORDINANCE AMENDING CHAPTER 5.08, "ALCOHOLIC BEVERAGES," SECTION 5.08.090, "LICENSE--NUMBER TO BE ISSUED," OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Title 5, "Business Licenses and Regulations," Chapter 5.08, "Alcoholic Beverages," Section 5.08.090, "License--Number to be issued," be and is hereby amended by deleting the phrase "twenty Class B," and substituting the following therefor: "twenty-one Class B."



That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


