


ORDINANCE NO. 97-M-18

**AN ORDINANCE AMENDING CHAPTER 13.12 "SEWERS"  
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE  
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 13.12 "Sewers," Section 13.12.830 "Charges for Residential Users" Paragraph A, Subparagraph One (1) of the St. Charles Municipal Code be and is hereby amended by deleting the same and substituting the following therefor:

1. The residential sewer user charge shall be billed monthly and shall appear on the monthly utility bill prepared by the city and shall be based on the water purchased by the user from the city during the winter quarter. The following rate shall be charged for sewer service to all residential users: six dollars and thirty-five cents demand charge per month plus two dollars and fifty-eight cents per one thousand gallons of water used. The calculations of the monthly sewer charge shall be computed as soon as possible after the winter quarter water billings have been completed, and such monthly user charge shall apply to billings sent to customers beginning in **April** of the same year and ending with billings sent in **March** of the following year.


2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles.


