ORDINANCE NO. 1997-M-73

AN ORDINANCE AMENDING CHAPTER 5.48 "CARNIVALS"
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. That Chapter 5.48 "Carnivals," Section 5.48.110 "License Fees,"
of the St. Charles Municipal Code, be and are hereby amended by deleting
the same the substituting the following therefor:

5.48.110 License fees.

- A. The following fees shall be paid prior to issuance of a
license hereunder:
1. \$200.00 - to operate a carnival; and
 - a. \$20.00 per ride;
 - b. \$15.00 - per amusement stand;
 - c. \$15.00 - per concession;
 - d. \$15.00 - per entertainment show inside or outside;
 - e. \$15.00 - per food stand;
 - f. \$15.00 - for any other attractions not necessarily
falling within the above listed.
- B. The following organizations are exempt from fees under this
chapter:
1. Not-for-profit religious or charitable institutions,
societies or organizations; provided, however, that no
part of the net earnings are retained or retainable by
the owner;
 2. Grammar, junior high and high schools located within
the city;
 3. Governmental units, boards, commissions and bodies duly
organized under the laws of the city, State of Illinois
and/or United States of America.

2. That after the adoption and approval hereof this Ordinance
shall (i) be printed or published in book or pamphlet form, published
by the authority of the Council, or (ii) within thirty (30) days after
the adoption and approval hereof, be published in a newspaper published
in and with a general circulation within the City of St. Charles.
However, this Ordinance shall not be effective before July 1, 1997.
