





ORDINANCE NO. 1997-Z-28

**AN ORDINANCE AMENDING TITLE 17, "ZONING", OF THE ST. CHARLES MUNICIPAL CODE REGARDING CHURCHES AND SCHOOLS, ELEMENTARY (NON-BOARDING) IN THE M-1 LIMITED MANUFACTURING DISTRICT**

WHEREAS, a petition has been filed by The Assembly of God Christian Center to amend Title 17, "Zoning" of the St. Charles Municipal Code with respect to the provisions of Chapter 17.36, "M-1 Limited Manufacturing District", Section 17.36.020 "Special Uses", by adding Q. "Churches" and R. "Schools, elementary (non-boarding)"

WHEREAS, the Plan Commission has held a public hearing on said petition in accordance with law; and

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered same; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

1. That Chapter 17.36 "M-1 Limited Manufacturing District", Section 17.36.020 "Special Uses", of Title 17, "Zoning", of the St. Charles Municipal Code, be and is hereby amended by adding items Q. and R. as follows:

Q. Churches

R. Schools, elementary (non-boarding)

2. That this ordinance shall become effective from and after its passage and approval in accordance with law.
