



AN ORDINANCE AMENDING TITLE 13, "PUBLIC UTILITIES"

CHAPTER 13.12 "SEWERS"

OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST.
CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. THAT TITLE 13, "Public Utilities", Chapter 13.12 "Sewers" of the St. Charles Municipal Code be and is hereby amended by deleting item 4 of section 13.12.840A and substituting the following therefore:

"13.12.840 User Charges for Metered Water Consumption and Nonresidential Use

A. The non-residential sewer user charge shall be as follows:

4. Nonresidential Users in a building with no water purchases and a sewer connection without flow measurement equipment shall be charged the existing nonresidential sewer demand charge per month, plus a user charge equivalent to six thousand gallons of usage at the existing nonresidential sewer use rate per one thousand gallons. Nonresidential Users may be required to install flow measurement equipment pursuant to the conditions setforth in Section 13.12.940B."

2. That after the adoption and approval hereof, this Ordinance shall (a) be printed or published in book or pamphlet form, published by the authority of the City Council, or (b) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on December 21, 1998, the Corporate Authorities of such municipality passed and approved Ordinance No. 1998-M-118, entitled
