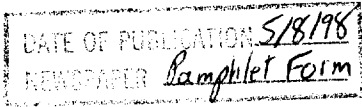

**An Ordinance Amending Title 2, "Administration and Personnel,"
Chapter 2.29, "Visitors Cultural Commission,"
Section 2.29.060, "Duties," of the St. Charles Municipal Code**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 2, "Administration and Personnel," Chapter 2.29, "Visitors Cultural Commission," Section 2.29.060, "Duties," Paragraph E, of the St. Charles Municipal Code be and is hereby amended by deleting the same and substituting the following therefor:

E. Make recommendations of a budget for the provision of services provided such budget shall be Sixty-Five (65%) percent of the amount estimated by the Finance Committee to be received by the city from the Municipal Hotel Operator's Occupation Tax pursuant to Chapter 3.32 of the St. Charles Municipal Code.

2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles.


I further certify that on May 4, 1998, the Corporate Authorities of such municipality passed and approved Ordinance No. 1998-M-29, entitled
