



AN ORDINANCE AMENDING CHAPTER 10.41,
"HANDICAPPED PARKING,"

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter. 10.41, "Handicapped Parking," Section 10.41.050, "Posting signs." of the St. Charles Municipal Code, be and is hereby amended by deleting Section B., and substituting:

"B. Municipal Parking Lot 'G,' west of Second Street (Route 31) between State Street and Cedar Street, four spaces as identified and properly signed (first space in the northwest section, last two spaces in the southwest section, and the last space in the southeast section of the facility). See Exhibit 'PL-G' 10.40.010."
2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


EXHIBIT "PL-G" 10.40.010


I further certify that on June 1, 1998, the Corporate Authorities of such municipality passed and approved Ordinance No. 1998-M-47, entitled
