ORDINANCE NO. 1998-M- 8

**AN ORDINANCE AMENDING CHAPTER 13.12 "SEWERS"
OF THE ST. CHARLES MUNICIPAL CODE**


**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Chapter 13.12 "Sewers," Section 13.12.840 "User Charges for Metered Water Consumption and Nonresidential Use," of the St. Charles Municipal Code be and is hereby amended by adding sub-paragraph number 4 as follows:
 4. Non-residential users in a building with no water purchases and with more than one non-residential unit with sewer connections shall be charged the existing non-residential sewer demand charge per month plus a user charge equivalent to six thousand gallons of usage at the existing non-residential sewer rate per one thousand gallons.
2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the city of St. Charles. This ordinance shall be effective immediately upon approval.


I further certify that on February 2, 1998, the Corporate Authorities of such municipality passed and approved Ordinance No. 1998-M-8, entitled
