



ORDINANCE NO. 1998-M- 82

**AN ORDINANCE AMENDING
TITLE 5, "BUSINESS LICENSES AND REGULATIONS,"
CHAPTER 5.36, "SOLICITORS,"
SECTION 5.36.030.B., "REGISTRATION - APPLICATION REQUIREMENTS,"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 5, "Business License and Regulations," Chapter 5.36, "Solicitors," Section 5.36.030, "Registration - Application Requirements," of the St. Charles Municipal Code, be and is hereby amended to read as follows:

- A. Section 5.36.030.B. is hereby deleted in its entirety.
- B. Section 5.36.030.C. is hereby re-lettered to 5.36.030.B.
- C. Section 5.36.030.D. is hereby re-lettered to 5.36.030.C.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on September 21, 1998, the Corporate Authorities of such municipality passed and approved Ordinance No. 1998-M-82, entitled
