



ORDINANCE NO. 1999-M- 44

AN ORDINANCE AMENDING TITLE 8, "HEALTH AND SAFETY"

CHAPTER 8.24 "GARAGE AND REFUSE",

OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST

CHARLES, KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:

1. THAT TITLE 8, "Health and Safety", Chapter 8.24 "Garbage and Refuse" of the St. Charles Municipal Code be and is hereby amended by deleting the following paragraphs: 8.24.010.H; 8.24.020.E; 8.24.030.A1.a; 8.24.030.A.1.b; 8.24.030.A.2; 8.24.040.B and substituting the following therefore as follows:

8.24.020 "E All recycling bins and totes shall remain the property of the City and the City's refuse contractor, respectively, and shall not be removed from the property on which the dwelling unit is located without the written consent of the Director of Public Works or his designee."

8.24.030.A.1. "a. All single-family dwellings and multi-family dwellings comprised of six (6) or less units (not in a complex of more than six total units) shall be picked up at the curbside, unless otherwise authorized by the Director of Public Works or his designee."

8.24.030.A.1. "b. All containers shall be placed in a manner readily accessible for collection immediately behind the curb (i.e., on the parkway) at the street or at the alley lot line, no earlier than 7:00 p.m. on the day preceding the day on which collection is scheduled. Employ containers shall be removed from the curb no later than 7:00 p.m. on the day of collection."

8.24.030.A. "2. Dwellings of six or more units: All multi-family dwellings comprised of six (6) or more units shall be provided a common garbage refuse container, and a recyclable materials container (dumpster, toter, or recycling bin as designated by the Director of Public Works or his designee).

8.24.040. "B.

B. The charges for garbage and rubbish, yardwaste and recyclable material collection service within the corporate limits of the City shall be as follows:

That after the adoption and approval hereof, this Ordinance shall (a) be printed or published in book or pamphlet form, published by the authority of the City Council, or (b) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


I further certify that on July 6, 1999, the Corporate Authorities of such municipality passed and approved Ordinance No. 1999-M-44, entitled
