



ORDINANCE NO. 1999-M- 77

**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC,"
CHAPTER 10.40, "STOPPING, STANDING AND PARKING,"
SECTION 10.40.045, "RESIDENTIAL PARKING ONLY,"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking," Section 10.40.045, "Residential Parking Only," of the St. Charles Municipal Code, be and is hereby amended as follows:

- (a) By amending Section 10.40.045.C to read as follows:
 - C On both sides of Fairfax Road from the westerly right-of-way of Dunham Road to the easterly right-of-way of Forest Ridge Road.

- (b) By adding subsection "I" to read as follows:
 - I On both sides of Huntington Road from the southerly right-of-way of Fox Chase Boulevard to the northerly right-of-way of Forest Ridge Road.

- (c) By adding subsection "J" to read as follows:
 - J On Forest Ridge Road along the westerly side of the street from the southerly right-of-way of Fairfax Road continuing westerly around the circle to the southerly right-of-way of Huntington Road.

- (d) By adding subsection "K" to read as follows:
 - K On the east side of Essex Court from the southerly right-of-way of Huntington Road to the southerly end of the Court.

(e) By adding subsection "L" to read as follows:

L. On the west side of Sterling Court from the northerly right-of-way of Forest Ridge Road to the northerly end of the Court.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
