**AN ORDINANCE AMENDING TITLE 2, "ADMINISTRATION AND PERSONNEL,"
CHAPTER 2.08, "CITY TREASURER,"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES, KANE
AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 2, "Administration and Personnel," Chapter 2.08, "City Treasurer," of the St. Charles Municipal Code, be and is hereby amended by adding the following therefor:

2.08.090 City Treasurer - Salary.

The salary for the City Treasurer shall be fixed at One Thousand Five Hundred (\$1,500) Dollars per year for attendance at City Council meetings and the performance of other duties prescribed by statute and ordinance.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


