



**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC,"
CHAPTER 10.11, "RULES OF THE ROAD,"
SECTION 10.11.2370, "RIDING IN BUSINESS DISTRICT,"
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.11, "Rules of the Road," Section 10.11.2370(A), "Riding in Business District," of the St. Charles Municipal Code, be and is hereby amended to read as follows:

Section 10.11.2370(A). Riding in Business District.

No person shall ride a skateboard in the city upon a sidewalk within a business district except as specified in this section. Whenever any person is riding upon a sidewalk, such person shall yield the right-of-way to any pedestrian and shall give audible signal before overtaking and passing such pedestrian. No person shall ride a skateboard on city property bounded by Main Street on the south, the south edge of the right-of-way of the Union Pacific Railroad on the north, 1st Avenue on the east, and the Fox River on the west.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.




I further certify that on December 20, 1999, the Corporate Authorities of such municipality passed and approved Ordinance No. 1999-M-94, entitled
