



ORDINANCE NO. 1999-M- 95

**AN ORDINANCE AMENDING TITLE 10, "VEHICLES AND TRAFFIC,"
CHAPTER 10.40, "STOPPING, STANDING AND PARKING,"
SECTION 10.40.020 and SECTION 10.40.040,
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic." Chapter 10.40, "Stopping, Standing and Parking," Section 10.40.020, "City Parking - Manner of Parking - Improper Parking - Curbs - Alleys - Loading Zones," of the St. Charles Municipal Code, shall be amended by adding the following:

Section 10.40.020.

(C)(2) On the south side of the 100 block of State Avenue, starting at a point 29 feet east of North 1st Avenue and extending easterly for 66 feet.

(C)(3) On the east side of North 1st Avenue, starting at a point approximately 90 feet north of Main Street and adjacent to the existing No Parking Zone and extending northerly for 46 feet.

2. That Title 10, "Vehicles and Traffic." Chapter 10.40, "Stopping, Standing and Parking," Section 10.40.040, "No Parking Places Designated - Prohibited Parking," of the St. Charles Municipal Code, shall be amended by deleting Exhibit "PL-M" dated December 26, 1996, and replacing said exhibit with Exhibit "PL-M" dated November 4, 1999, attached hereto and incorporated into this ordinance by reference.

3. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.






I further certify that on December 20, 1999, the Corporate Authorities of such municipality passed and approved Ordinance No. 1999-M-95, entitled
