**AN ORDINANCE AMENDING TITLE 17
OF THE ST. CHARLES MUNICIPAL CODE
CHAPTERS 17.24, 17.25, AND 17.28 REGARDING LIVE ENTERTAINMENT AND
DANCING**

WHEREAS, a Petition has been filed to amend Chapters 17.24 B-2 Community Business District, 17.25 B-2-C Central Business District and 17.28 B-3 Service Business District; and

WHEREAS, the Plan Commission of the City of St. Charles has held a public hearing on said Petition in accordance with law; and

WHEREAS, the City Council of the City of St. Charles has received the recommendation of the Plan Commission and has considered the same;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of St. Charles, Kane and DuPage Counties, Illinois, as follows:

SECTION 1. That Chapters 17.24 B-2 Community Business District, 17.25 B-2-C Central Business District and 17.28 B-3 Service Business District be and is hereby amended as noted on the attached Exhibit A.

SECTION 2. That after the adoption and approval hereof this Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

Amend Chapter 17.24 B-2 Community Business District, Section 17.24.020 "Permitted Uses" by deleting number 51. "Restaurants, when no entertainment or dancing is provided" and substituting the following language "Restaurants"

Amend Chapter 17.24 B-2 Community Business District, Section 17.24.030 "Special Uses" by adding letter U. and the following "Outdoor live entertainment or amplified sound in conjunction with a restaurant, tavern or cocktail lounge. Such outdoor live entertainment shall not occur past 10:00 p.m. and shall not generate sound levels in excess of 60 dBA as measured from the property line in any residence district."

Amend Chapter 17.25 B-2-C Central Business District, Section 17.25.030 "Permitted Uses" by deleting number 70. "Restaurants, when no live entertainment or dancing is provided" and substituting the following language "Restaurants"

Amend Chapter 17.25 B-2-C Central Business District, Section 17.25.030 "Permitted Uses" by deleting number 78. "Taverns and cocktail lounges, when no live entertainment or dancing is provided" and substituting the following language "Taverns and cocktail lounges"

Amend Chapter 17.25 B-2-C Central Business District, Section 17.25.040 "Special Uses" by deleting number 15. "Restaurants, taverns and cocktail lounges, including live entertainment or dancing" and substituting the following "Outdoor live entertainment or amplified sound in conjunction with a restaurant, tavern or cocktail lounge. Such outdoor live entertainment shall not occur past 10:00 p.m. and shall not generate sound levels in excess of 60 dBA as measured from the property line in any residence district "

Amend Chapter 17.28 B-3 Service Business District, Section 17.28.020 "Permitted Uses" by deleting number 38. "Restaurants, including live entertainment and dancing".

Amend Chapter 17.28 B-3 Service Business District, Section 17.28.030 "Special Uses" by adding letter K. and the following language "Outdoor live entertainment or amplified sound in conjunction with a restaurant, tavern or cocktail lounge. Such outdoor live entertainment shall not occur past 10:00 p.m. and shall not generate sound levels in excess of 60 dBA as measured from the property line in any residence district "


I further certify that on November 1, 1999, the Corporate Authorities of such municipality passed and approved Ordinance No. 1999-Z-20, entitled
