



ORDINANCE NO. 2000-M- 10

AN ORDINANCE AMENDING TITLE 10 "VEHICLES & TRAFFIC"  
CHAPTER 10.11 "RULES OF THE ROAD" SECTION 10.11.1600  
"THROUGH STREETS" OF THE ST. CHARLES MUNICIPAL CODE

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10, "Vehicles and Traffic," Chapter 10.11 "Rules of the Road", Section 10.11.1600 "Through Streets" of the St. Charles Municipal Code, shall be amended by adding subparagraph 21 and 22 to read as follows:

21. Peck Road from the northern city limits to Bricher Road except at the intersection with Main Street and the Intersection with Lincoln Highway.

22. Campton Hills Drive from Main Street to Happy Hills Road, except at the intersection with Main Street.

2. That after the adoption and approval hereof, this Ordinance shall be (i) printed or published in book or pamphlet form, published by the authority of the Council; or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.






I further certify that on February 21, 2000, the Corporate Authorities of such municipality passed and approved Ordinance No. 2000-M-10, entitled
