**ORDINANCE NO. 2000-M-105**

**AN ORDINANCE AMENDING TITLE 2  
"ADMINISTRATION AND PERSONNEL,"  
CHAPTER 2.27 "SENIOR SERVICES COMMISSION"  
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DU PAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 2, "Administration and Personnel," Chapter 2.27 "Senior Services Commission," Section 2.27.30, "Members – appointment." of the St. Charles Municipal Code, be and is hereby amended by deleting the same and substituting the following therefore:

**2.27.30 Members – appointment.**

The mayor with the approval of the city council shall appoint six members from the at-large community and five members from residential facilities dedicated to serving seniors. In addition, the mayor shall appoint a City Council member as an ex-official member of the commission.

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.


