ORDINANCE NO. 2000-M- 86

**AN ORDINANCE AMENDING TITLE 10
 "VEHICLES AND TRAFFIC" CHAPTER 10.40
 "STOPPING, STANDING AND PARKING" SECTION 10.40.020
 "CITY PARKING-MANNER OF PARKING-IMPROPER PARKING-
 CURBS-ALLEYS-LOADING ZONES" OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,
 KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10 "Vehicles and Traffic" Chapter 10.40 "Stopping, Standing and Parking", Section 10.40.020 "City Parking-Manner of Parking-Improper Parking-Curbs-Alleys-Loading Zones" and Section 10.40.040 "No Parking Places Designated-Prohibitive Parking" shall be amended as follows:

- A. Section 10.40.020C shall be deleted in its entirety;
- B. Section 10.40.020F shall be deleted in its entirety.
- C. That Section 10.40.040T is created and shall read as follows:

It is unlawful for any person to cause, allow, or permit a vehicle to stop for any purpose or length of time other than the period of time necessary for the expeditious unloading and delivery or pick-up and loading of materials in any place designated by ordinance by the Mayor and City Council as a freight loading zone and marked as such during the hours from 8:00 a.m. to 6:00 p.m., and in no case shall such vehicle stop for a period of time in excess of thirty minutes, or for loading and unloading of passengers in any place designated by ordinance by the Mayor and City Council as a loading zone and marked as such, or in any of the following designated places:

- 1. Freight Loading Zone
 - a. On the west side of south 1st Street from the northerly right-of-way of Prairie Street to a point 143 feet northerly therefrom.

- b. On the south side of the 100 block of State Avenue, starting at a point 29 feet east of North 1st Avenue and extending easterly for 66 feet.
- c. On the east side of North 1st Avenue, starting at a point approximately 90 feet north of Main Street and adjacent to the existing no parking zone and extending northerly for 46 feet.
- d. On the east side of North 3rd Street starting at a point 85 feet north of Main Street and extending northerly thereof for 85 feet.

2. Loading Zone

- a. Along the curb adjacent to the entrance to a hospital or hotel, provided the space shall not exceed 75 feet.
- b. Along the curb adjacent to the entrance to a public building between 6 a.m. and 6 p.m., except on Sunday, provided the space shall not exceed 75 feet.
- c. Directly in front of the entrance to any theater at any time the theater is open, provided the space shall not exceed 75 feet.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.




