AN ORDINANCE NO. 2000-M - 95

AN ORDINANCE AMENDING CHAPTER 10.40,
"STOPPING, STANDING AND PARKING,"
OF THE ST. CHARLES MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF
ST. CHARLES, KANE AND DU PAGE COUNTIES, ILLINOIS, AS
FOLLOWS:

1. That Title 10, "Vehicles and Traffic," Chapter 10.40, "Stopping, Standing and Parking," Section 10.40.060, "Snow Routes - Designated - Removal of Vehicles Required - Sign Erection Authorization," of the St. Charles Municipal Code, be and is hereby amended by adding the following revised text:

1. 37. Campton Hills Road from Main Street to Happy Hills Road
38. Peck Road, from Illinois Route 38 to Main Street

2. That after the adoption and approval hereof the Ordinance shall (i) be printed or published in book or pamphlet form, published by the authority of the Council, or (ii) within thirty days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.
