



ORDINANCE NO. 2001-M- 12

**AN ORDINANCE AMENDING TITLE 10  
“VEHICLES AND TRAFFIC” CHAPTER 10.40  
“STOPPING, STANDING AND PARKING” SECTION 10.40.040  
“NO PARKING PLACES DESIGNATED-PROHIBITED PARKING”  
OF THE ST. CHARLES MUNICIPAL CODE**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ST. CHARLES,  
KANE AND DUPAGE COUNTIES, ILLINOIS, AS FOLLOWS:**

1. That Title 10. “Vehicles and Traffic” Chapter 10.40 “Stopping, Standing and Parking”, Section 10.40.040 “No Parking Places Designated-Prohibited Parking”, of the St. Charles Municipal Code, shall be amended as follows:

A. By amending Section 10.40.040T by adding 1e to read:

On the east side of north First Avenue starting at a point 34 feet south of State Avenue and extending southerly thereof for 43 feet.

2. That after the adoption and approval hereof, this Ordinance shall (i) be printed or published in book or pamphlet form published by the authority of the Council, or (ii) within thirty (30) days after the adoption and approval hereof, be published in a newspaper published in and with a general circulation within the City of St. Charles.

3. This Ordinance shall be in full force and effect from and after its passage by a vote of the majority of the corporate authorities now holding office and approval in the manner provided by law.




